Pravara Rural Education Society's , College of Pharmacy ,(For Women),Chincholi Nashik. represented herein by its Dr.Charushila Jayant Bhangale (Principal) here in after referred as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

AND

Sangeeta Pharma ,Malegaon Industrial Area, Malegaon, Maharashtra 422113 and represented herein by its Head, _____, (Director) (here in after referred to as "**Second Party**", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;
- E) Sangeeta Pharma ,Malegaon Industrial Area, Malegaon, Maharashtra 422113 the Second Party is engaged in Production and R&D Services in the fields of Pharmaceutical .
- F) Give related information, its branches, and dimensional information about the industry

concerned with which the MoU is sworn.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry.
- 1.3 The general terms of co-operation shall be governed by this MOU. 

This Memorandum of Understanding entered on the 23 Day of April 2022 between AVODHA EDUTECH Pvt. Ltd. 



The purpose of this MOU is to set forth the terms and conditions under which the parties to this understanding shall conduct themselves during the subsistence of the memorandum.

1. The First Party shall make all arrangements to enable the Pravara Rural Education Society's College of pharmacy (For women) chincholi, as the learning hub of AVODHA EDUTECH, for all the sixteen Certificate Courses. (Annexure I)
2. The Course duration shall be a minimum of 3 months extendable to one year
3. The First Party shall also provide placement assistance for a period of five ears (during which internship can also be availed) Students are moved into the placement assistance stage of the service only once they attain course completion which is defined as completing the online course personalized training and Mock Interviews.
4. The First Party shall provide students an option to attempt for authorized certification of multinational companies or the certification of government /semi-government agencies. The prices listed in Annexure IV may vary according to the dollar value changes and update in the examination fees or registration fees for authorized certifications of multinational companies or the certification of government /semi-government agencies.
5. The Second Party will provide all necessary infrastructure including classroom facilities, computers, electrical power, etc. to the possible extent. The College will have full control on all items said above and will provide the required services. It would even maintain the computers and accessories to the rest of their ability and would regularly pay the electricity and other related expenses"
6. The First Party will arrange to install the required softwarees for use and to the best satisfaction of the students as per course specifications. They shall also ensure the maintenance and updates of the software periodically if any"
7. The date and time of the classes will be finalized on mutual discussion and can be changed or altered on mutual agreement.
8. In order to enroll for a programme candidates will have to remit to the College Office the course fee of Rs. 3,800/- [Rupees Three Thousand eight hundred only] and (in the case of students seeking authorized certifications) the Registration and Examination fees specific to each programme must be paid separately. (Annexures III & IV)



9. The Second Party shall reimburse the First Party the course fee of RS 2800/- per student at the commencement of the programme.

10. The First Party shall ensure that every student understands the portions by evaluating their knowledge using a self-assessment test after each module and providing assignments to make them proficient in practical application.

11. The First Party shall allot' students to opt for any one or combo training programmes among these courses in Annexure I and also provide the option to change the course if they so require.

12. The first Party shall give the students the option to do the combo programmes either one programme each a year or all the three programmes in the first year followed by internships (extendable to three years, applicable only if three programmes are done in the first year itself).

B. If any binding agreement becomes unenforceable due to any regulatory or statutory requirement /compulsion.


